Terms and Conditions:-

1. The auction shall be conducted at 2.00 p.m. on 24-09-2015 at the ground floor of the office of Patent Information System/Rajiv Gandhi National Institute of Intellectual Property Management , 3 Hislop College Road, Civil Lines, Nagpur.
2. Every bidder shall bring only two members from his side who shall be given entry in the office premises.
3. The Earnest Money Deposit of the highest bidders whose bids have been accepted will be adjusted towards the sale price. These highest bidders shall sign the bid sheet on which proceedings of auction are recorded in

token of having offered the highest bid and abiding the terms of auction. The EMD of the 2nd highest bidder will be retained till the highest bidder accepts the offer of sale and completes the deal. EMD shall be 25% of the bid value and shall be paid in cash.

4. The bidder in whose name the auction will be confirmed shall pay in cash the accepted bid of the entire amount on the spot. In case of failure of removal of auctioned item/items within five days from the date of auction, the EMD shall be forfeited to Govt. without prejudice to the terms and conditions of the contract.
5. The delivery of the auctioned material shall be given only on the full payment of amount of the accepted bid on the entire amount. No transportation charges will be borne by this office.
6. No Complaint about the stores will be entertained after the auction. The materials shall be sold on "As is and where is" and "No Complaint" Basis. So the bidders should satisfy themselves about the condition of the materials, before bidding. After the auction of the same is over, the responsibility of the auctioned materials will rest with the purchaser.
7. The auctioned materials should be removed from the office premises immediately within 5 days by successful bidder after payments. The office shall not take any responsibility for any kind of damage/loss/theft etc. thereafter.
